First aid measures

4.1. **Description of first measures:**

General advice: Remove contaminated clothing.

If inhaled Remove to fresh air. If rapid recovery does not occur, transport to nearest medical facility for

additional treatment.

In case of skin contact Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if

available. Do not use solvents or thinners. In case of irritation consult with doctor.

Flush eyes with water while holding eyelids open. Rest eyes for 30 minutes. If redness, burning, In case of eye contact

blurred vision, or swelling persist, transport to the nearest medical facility for additional treatment.

If swallowed If swallowed, do not induce vomiting: transport to nearest medical facility for additional treatment. If

vomiting occurs spontaneously, keep head below hips to prevent aspiration.

7.1. Precautions for safe handling:

Advice on safe handling:

Inventory levels at the workplace must be restricted. Use only in well ventilated areas. Vapors and spray mists. Avoid contact with eyes and skin. Do not spray on a naked flame or any incandescent material. Prevent the creation of flammable or explosive concentrations of vapor in air and avoid vapor exposure limits. Advice on protection against fire and explosion
